Ms. Bangs will present a fast-moving seminar to review in detail the steps necessary (legally and procedurally) to follow before, during and after furnishing labor, equipment or materials to the work of improvement to assure a valid Stop Payment Notice and/or Bond Claim on a Private or Public Works project.**

**Ms. Thorsen will present on the bonding process to include bid bonds, performance bonds and payment bonds. She will also provide necessary documentation for you to start the process of establishing a surety bond line.**

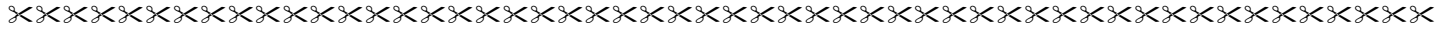
